3. APPROVAL OF MINUTES FROM October 6, 2014

4. REPORTS:

A. FIRE DEPARTMENT: Two reports submitted – 5 calls (quiet month) Discussion about Fire Dept members taking over the Suburban that is currently being maintained by the Village to be the Chief's vehicle. Also talked about taking the Tahoe off the road. The chief verified that the village would cover the cost of the generator maintenance, since they cover fire extinguishers. Brief discussion of why the fire dept wants to do take over the Suburban and developing specific use plan for vehicle. Gayle asked Chief about the whereabouts of the key to the thermostat. The chief also indicated the fire department, likely, does too few calls to be considered for free air packs according to Angelo Santabarbara

- B. TREASURER/CLERK: Tax searches bring in \$10 in revenue. Bruce is setting up a tax search request form on our webpage. Discussion of clerk duties and availability. Job descriptions are a work in progress. Salary changes will be discussed during budget time.
- C. WATER DEPARTMENT: Reports submitted. Telephone still not working at plant. Jeff suggested both trustees go on tour of the water plant on Saturday. UV bulbs will be discarded with our garbage. FEMA project is complete at lower reservoir. Discussion about taking advantage of frozen ground and obtaining permit for next FEMA project. Lights and ballards installed but the project went over budget approx. \$1118. Trustee O'Connor made motion to pay overage & Trustee Grenier seconded it.
- D. PLANNING BOARD: Met in Gayles office while we met. Al Zubal, Dan Lindh and Dan Coombs all received training certificates.

drainage & repair and street sign replacement. Received 2 quotes for street sign replacement. Board agrees to purchase for lesser quote of \$1726. Money for he street signs is reimbursable through the CHIPS fund.
