#### VILLAGE OF DELANSON MINUTES June 10, 2013

### 1. PLEASE STAND FOR THE PLEDGE OF ALLEGIANCE

- MEETING CALLED TO ORDER: 7:00 P.M. ALL PRESENT: Mayor Gifford, Trustee O'Connor, Trustee Greiner, Clerk Grasek, Chief Morrison, Water Commissioner Iveson
- 3. APPROVAL OF MINUTES FROM May 13, 2013 MOTION TO ACCEPT: Trustee O'Connor 2<sup>ND</sup> Trustee Grenier. Passed 3 ayes

#### 4. REPORTS:

A. FIRE DEPARTMENT:62 calls, 7 fire calls this month, 9 medical calls. Chief Morrison informed the board that the Fire Co received a Chevy Tahoe vehicle from another Fire Co. The Fire Co will maintain the vehicle; the Village will pay the insurance on the vehicle. Chief Morrision also told the Board that the prior administration had granted him a \$100 a month gas allowance for the use of his private vehicle.

C. WATER DEPARTMENT: report attached, discussion regarding High School Valves and maintenance. The Community Center is interested in purchasing water from the Village. Mayor Gifford will contact them regarding the charge for this service.

F. PUBLIC WORKS: Steve Perog was present and is interested in doing consulting work for the Village in regards to public work contracts. The Board asked him to present a proposal in regards to the work he wishes to do and the compensation.

G. BUILDING INSPECTOR: Report filed. It was reported that the building inspector did work regarding the solar panel at the High School. The Board questioned why that would constitute work for the Village when the school said we had no jurisdiction in that matter.

5. NEW BUSINESS:

A. Resolution to modify 2012-13 operating budget

Resolution 2013-04-01 Be it resolved that the following budget accounts be modified, as directed below to the 2012-13 Budget

Increase A-1620.2 (Equipment) by \$6560.82 from A-2630 Insurance recovery to compensate for the boiler and cost of installation.

Increase F-8330.44 (other Contractual) by \$1,046.03 from F-4685 FEMA Recovery to compensate Sally Burns, Jeff Iveson, and Steve Michelli for Direct Administrative costs related to preparing FEMA project worksheets.

Motion to pass resolution 2013-01-01 Trustee O'Connor, 2<sup>nd</sup> Trustee Grenier, motion passed.

B. Certificate of Records Destruction – Motion to accept list and send for destruction Trustee O'Connor, 2<sup>nd</sup> by Trustee Grenier motion passed

C. New Clerk, Treasurer and office procedure- Mayor Gifford has appointed Penny Holbrook to the position of Village Clerk, effective 6/11/13 to 3/31/14.

D. Public Works Consultant discussion – Steve Perog discussed the paving of Village Roads. He suggested piggy backing with the County for Road resurfacing. The shoulder on Thousand Acre Road needs to be fixed and the old electric poles need to be removed before the roads can be paved.

E. FEMA- discussion on projects still needing to be finished

F. Website – Bruce Barton sent a letter to the board regarding changes needed to be done on the Village Website. He is willing to design, maintain and host our website for no compensation. He has contracted with Blue Host for this first year and if the Village wants to keep that hosting company they will pay directly next year. Motion by Trustee O'Connor to update the website per Mr. Barton's recommendations and to reimburse Mr. Barton for Blue Host for one year at a yearly fee of \$83.40 . 2<sup>nd</sup> by Trustee Grenier.
