Did You Know...

It is illegal To Plow Snow into A Street or Highway?

Winter is upon us, snow becomes the prevalent topic of conversation. With snow storms also comes the need for plowing, shoveling, and snow blowing of driveways, side-walks and parking lots.

Did you know that it is illegal to plow, shovel, or use a snow blower to put snow in a street or highway? Section 1219 of New York State Vehicle and Traffic Law prohibits doing this, along with other items likely to pose a hazard to motorists, including glass, nails, wire, cans, etc. and SNOW. Fines for a first offense include a \$100 fine and/or 15 days in jail, plus applicable surcharges.

This also means that, if you are a homeowner, and you hire a person to plow your driveway, and you permit him/her to plow the snow into the road, you could also be cited under this law.

So, even if the easiest way to rid your driveway, parking lot, or sidewalk of snow is to put it into the

street or road and hope the next pass of the plow will take care of it, take note of this law and find



another place to put the snow.

Please clear nearby fire hydrants

If you have a fire hydrant in front of or near your home, please make an effort to clear any snow and ice from around the hydrant. The effort could be a joint project between

several neighbors. In the event of a fire, the time spent by firemen clearing snow or ice from a hydrant could make a difference in the amount of damage done by the fire.

Please shovel your sidewalk.

Homeowners with a sidewalk in front of their home are responsible for keeping the sidewalk clear of snow and ice. We appreciate your consideration ... Thank you!

Snow from your driveway should never make it to the road. It is essential to clear snow from your car's roof, windshield, trunk and hood before you drive. Also make sure the headlights and taillights are clear. Snow left on vehicles roof can blow off onto the windshield of vehicles behind you causing an accident. In addition to causing accidents, failure to heed this advice can get you a traffic ticket.

Damage to mailboxes: Highway crews do their best to avoid mailboxes, but often times visibility, oncoming traffic and

heavy snow work against them. The best method to protect your mailbox during the winter



months is to ensure it is properly attached to the post and to keep the mailbox assembly simple to limit impact surface area for plowed snow. If damage is caused by snow removal, it is not done intentionally. It is, however, an unfortunate consequence of snow removal. As far as the particular agencies replacing damaged mailboxes,

it must be pointed out that there is no statutory or legal authority requiring them to do so. In fact, under Section 319 of the New York State Highway Law, mailboxes are considered high-way obstructions and are only "allowed" in the right-of-way as a convenience to the owner as it is understood they are required for mail delivery. Agencies may be inclined to replace a damaged mailbox under certain circumstances and at their discretion, if the damage was caused by the plows physically striking the mailbox. Typically, damage is caused by the weight of the snow being plowed off the road, in which case, the home-owner would be responsible for repair costs. Does your mailbox meet USPS specifications? Please drive safe and be patient Highway agencies spend a consider-able amount

of tax money to ensure the roads are cleared in an efficient manner after snow and ice events. Snow removal efforts do not guarantee bare or dry roads. The cos to provide these conditions would far outstrip what most tax payers would be willing to pay. Even when bare roads can be obtained, weather conditions such as wind and rapidly dropping temperatures can alter highway conditions dramatically from one area to the next. The best course of action for anyone traveling during the winter months is to adjust your driving to meet the conditions present. Allow for road conditions by leaving a little early, be patient and slow down.

Electronics Disposal Ban

As of January 1, 2015 – the full electronic disposal ban New York is in effect. Businesses and households are no longer allowed to dispose of their e-waste by placing it for collection intended for processing at a solid waste or hazardous waste management facility. In short, you can't place e-waste at the curb or give it to a company who is not a registered e-waste collector, consolidator or recycler. As a result, the Town Highway Department will no longer be hosting the annual clean up day.

Electronic Equipment Covered by the Law:

- **Computers** (including laptops, desktops, tablets and e-readers) Consumers should erase all personal and confidential data before sending it for recycling or reuse. Reformatting your hard drive or deleting files does not destroy your data. Manufacturers must provide information on their public education websites on how consumers can destroy the data contained in their electronic waste. As previously mentioned, manufacturers may offer data security services as part of the electronic waste acceptance program, and may charge a fee for this type of "premium service". As a community service, Home Electronic Services of Delanson is offering Village of Delanson residents complete & secure data removal from old computers for FREE! 
DFC Fancake Breakfast

Email Notification System

The Village of Delanson has initiated an Email Notification system whereby residents can be notified by email immediately of important information or any emergency situation that has developed in the Village. Examples would be water main brakes, water main repairs, hydrant flushing, sudden changes in Village services such as garbage pickup or snow plowing, flooding, road closings, damaged roads etc.. Emails will not be sent for normal news items, notices or scheduled events. In addition, updates will be emailed to keep residents informed of the ongoing circumstances as new information is received by the Village until the event or emergency is over.

There is no cost for this service. Please go to our website, www.delanson.net and on the home page on the left side enter your email address. You will receive an email asking you to confirm your decision to receive these bulletins. Once we receive your confirmation, you will be added to our mailing list to receive theses notices. Your privacy is important to us, so your email address will not be shared, sold or used in any other capacity and you may unsubscribe at any time by clicking on the unsubscribe link on any email you receive or by contacting the web master at webmaster@delanson.net. We hope this new feature will not only help keep our residents not only well informed but safer during emergency situations.

Leash Law in Effect



Please call animal control officer Darla Gullotta at 860-3179 if you see a pet running loose, the owner will be grateful you did. Thank you for cleaning up after your pets, your neighbors appreciate your consideration. Remember Village Law prohibits the feeding of animals outdoors. All dogs must be licensed; contact the Village Clerk.

At a regular meeting of the Delanson Village Board on January 12, 2015, a resolution was passed to allow the Schenectady County Board of Elections to conduct all future Village General Elections. Residents still request nominating petitions and absentee ballots from the Village Clerk and we will also select the election inspectors as we always have. All costs of administrating the Village elections will be absorbed by the Board of Elections, saving the Village hundreds of dollars each election year.

VILLAGE GENERAL ELECTIONS are elections that only Village residents are allowed to participate in. Residents vote for one Mayor and two Trustees and the candidates are your neighbors and friends. You must be 18 years of age, a resident of the Village for at least 30 days, a US citizen and registered to vote in Schenectady County. Terms of office are currently 4 years and elections are held in March.

There are no designated parties here in Delanson. Candidates are simply residents with a desire to be a positive contributor in the community in which they were raised or are raising their family. Candidates choose their own party name and symbol... one that best describes what they wish to accomplish.


If you want an opportunity to make great things happen in your community, you have that privilege. The next Village General Election will be held in March of 2017. Residents will vote for one Mayor and one Trustee for a 4 year term. Our Village remains one of over 500 independent communities in New York State. We are relatively young at just 6 years shy of 100! The next administration will have the honor of organizing our 100th Anniversary in 2021. That is a great thing!

Water Rents

WATER RENTS are billed quarterly in July, October, January and April

4th Quarter - April - June due w/o penalty during April

1st Quarter - July through September due without penalty during July 2nd Quarter - October through December due w/o penalty during October 3rd Quarter - January through March due w/o penalty during January



Payments must be received no later than April 30th. Payments received after April 30th will be returned. Unpaid water rents for all Village Residents are re-levied May 15 annually to Village Tax.



Two Ways to Recycle Your Electronic Waste

Option 1: Use a Manufacturer's Takeback Program

- 1. **Go to DEC's** list of electronic equipment manufacturers registered in NYS, to find manufacturers, their brands electronic equipment covered by the law, and their electronic waste acceptance program websites and toll-free telephone numbers.
- 2. Follow the specific instructions listed on the manufacturer's website or provided over the telephone.

 The manufacturer is required to provide information on how to recycle your equipment, free of charge. Please note: Manufacturers are required to accept their own brand of electronic equipment for recycling. They are also required to accept one piece of electronic waste of any manufacturer's brand if offered by a consumer with the purchase of electronic equipment covered by the law of the same type by a consumer.
 - **Example:** If you purchase a new ABC-branded television and wish to recycle your old XYZ-branded television, you may use any free and convenient acceptance method provided by either ABC's or XYZ's manufacturer electronic waste acceptance program.

Option 2: Go to an Electronic Waste Collection Site

Residents in any part of the state can download the list of registered NYS Electronic Waste Collection Sites from the state website), sorted by county, to find a collection site near them.

Call ahead before using an electronic waste collection site as the site listed may not accept your particular type or brand of equipment. If the collection site is not affiliated with a manufacturer's acceptance program, **you may be charged a fee** to recycle your equipment. If you are looking for a free and convenient way to recycle your equipment, please first follow the Manufacturer Takeback Program steps above.
