VILLAGE OF DELANSON MINUTES March 9, 2015

- 1. PLEDGE OF ALLEGIANCE LEAD BY MAYOR GIFFORD
- 2. MEETING CALLED TO ORDER: 7:02 P.M.

ALL PRESENT: Mayor Gifford, Trustee O'Connor Trustee Grenier, Chief Morrison, Water Commissioner Iveson(Excused), Clerk Mormando, Ron Holbrook

- 3. APPROVAL OF MINUTES FROM February 9, 2015
 MOTION TO ACCEPT: Trustee O'Connor 2nd: Trustee Grenier
- 4. APPROVAL OF MINUTES FROM Budget Workshop February 23, 2015 MOTION TO ACCEPT: Trustee Grenier 2nd: Trustee O'Connor
- 5. PUBLIC HEARING ON LOCAL LAW TO OVERRIDE PROPERTY TAX CAP 7:15pm All those wishing to speak have spoken, floor closed at 7:31PM

Ron Holbrook asks about capital projects. He asks what projects the Village has that would warrant the new proposed law. The board explains that they hope to avoid using the law, but would like to have it in place just in case it's necessary. The board goes on to explain that the cost/price of things keeps going up, but the budget stays the same. Trustee O'Connor speaks about the highway department's charges are going up, price of garbage collection will likely go up and the cost of insurance for the Village is going up. The question is raised about dissolving the village into the Town of Duanesburg, but after a brief discussion it is determined this will likely not save the Village any money.

Discussion: Mayor Gifford gave overview of the law and purpose.

A. FIRE DEPARTMENT: 20 calls, Key system was installed with software on fire department's computer. Mayor Gifford & Trustee O'Connor think that the software should also be available on the Mayor's computer. Price of putting software on second computer needs to be obtained. Two doors

still need to be rekeyed(1 for each of us and 1 for Chief Morrison). Mayor Gifford would also like a key to Chief Morrison's office. New recruit Aaron Kellerman will be doing training. Chief Morrison has submitted grant for retention of current members and recruitment of new members for \$20,000. The fireman's banquet will be on April 11th.

- C. WATER DEPARTMENT: Report submitted. Trustee O'Connor suggests putting of hydrant flushing until the weather warms up to alleviate further stress on the pipes.
