## VILLAGE OF DELANSON MINUTES February 13, 2017

## 1. PLEDGE OF ALLEGIANCE LEAD BY MAYOR GIFFORD

2. MEETING CALLED TO ORDER: 7:05 P.M.

ALL PRESENT: Mayor Gifford, Trustee O'Connor, Trustee Grenier, Chief Morrison, Water Commissioner Iveson(Excused), Clerk Mormando, Al Zubal, Troy Miller

3. APPROVAL OF MINUTES:

Regular Board meeting January 9, 2017 - TABLED

MOTION TO ACCEPT: 2<sup>nd</sup>

4. Fire Chief Report – 17 Calls. Kevin filed an extension on the \$10,000 grant which he wants to use partly for turn out gear for new members. The extension will go until July. March 5<sup>th</sup> is the next pancake breakfast.

5. Troy Miller – Proposed Apartment Complex presentation – Troy has revised his proposal from 72 apartment units to 46. He explained this should lessen the impact a great deal on the water system for the Village. Brief discussion about possible impact of the apartment complex on the water system.

Trustee O'Connor suggests that the Village should consider <u>adopting a PUD to help with planning</u> and proposals. There was a discussion about this. <u>It was suggested by the Board that Troy provide the village board with a suggested edit to our zoning law that provides language relevant to planned unit development. He agreed to do so.</u>

6. REPORTS:

- A. FIRE DEPARTMENT: See Report above
- B. TREASURER/CLERK: Budget transfers were signed by the Board

C. WATER DEPARTMENT: Hydrant flushing had late notice. There were a couple of complaints from residents because they didn't know about the flushing. Mayor Gifford indicated hydrant flushing notice must be more timely. Chief Iveson did not flush hydrants on Stewart, East Shore & West Shore.

D. PLANNING BOARD: The Planning Board would like the Village to send a letter to the man

with the Bus Repair shop to inform him that he needs to apply for a special use permit. Mayor Gifford agrees.

E. ZONING BOARD OF APPEALS: Did not meet

F. PUBLIC WORKS: Lots of plowing happening. There was one complaint about a resident plowing the road.

G. BUILDING INSPECTOR: No Report

H. ANIMAL CONTROL: The Village Board accepted Darla Gulotta's resignation. Darla resigned but will work until the end of March. There are 2 very qualified candidates being considered for her position. The Village will contract with whoever the Town of Duanesburg chooses for the position.

Mayor Gifford will ask Dale to write a 2<sup>nd</sup> letter to the owner of the property to insist that site is covered adequately until it is cleaned up. Floor closed at 9:06
