4. REPORTS:

A. FIRE DEPARTMENT: 8 Calls, Mayor will call Mike about getting the generator and replacing the electric and hooking up cameras, Trustee O'Connor found a 6 camera system for \$600, Trustee O'Connor suggests having W&E Phillips Locksmith tweek the quote a little, remove the monitor and perhaps 2 less cameras. Kevin asks about dumpsters for cleaning out the shed(s). Kevin would like to get rid of about 30 air packs that were donated to the fire dept. Mayor Gifford says equipment needs to be declared surplus before disposal. Commissioner Morrison will make a list.

C. WATER DEPARTMENT: Commissioner Iveson reported Health Dept called to give a warning about some significant fines coming our way. The Health Dept. also said notifications must be sent to the residents describing the violations by Oct. 15. Mayor Gifford also had a discussion with Jack Frame and confirmed EPA is aggressively responding to towns and villages with a history of violations with heavy fines. Discussion about water problems and possible solutions. Trustee O'Connor suggests holding a forum to discuss upgrading the water system next year. Discussion about sealing the clear wells & installing another meter. Mayor Gifford will apply for another grant to DASNY to repair the clear wells, but needs a quote & plan from Francois. Commissioner Iveson will call him tomorrow to set up an appointment. Mayor Gifford has two specific times Donna can come to meet about adjusting the Dig Safety parameters. Commissioner Iveson indicates October 23rd at 4pm. Mayor Gifford will confirm with Donna.
