4. Shared Services Consortium Solar Presentation – GE International Inc. – working with the County for Municipal reasons on an RFP to build 46 Watts. They will provide 3 times as much power than the County will need & they will explain why. 3 sites identified in Delanson and 3 in Duanesburg. Discussion about this project. If the Village provides the land, it get more bill credits. If there is excess energy, they would look to giving credits to the school or nearby counties. Trustee Grenier asks about maintenance and how often they are maintained, Waller answers that they are only maintained a couple of times a year. Discussion about the solar projects next to the reservoir. Chuck Buccino asks if there is a fire protocol.
