4. Lamont Engineers Water Project Presentation

Jason Preisner report:: We are under review by the EPA. Jason submitted a letter that was sent to the EPA with a timeline for us to come into compliance from 2019-2024. We should apply for a grant. The EPA will help with the Department of Health to apply. Jason submitted steps to completing a municipal capital project. Possibly we act as lead agency and Duanesburg as second. Mayor Gifford discussed the bonding process. Mayor Gifford suggests having a workshop to discuss the water system with the Superintendent of Duanesburg (Roger Tidball) attending. Molly will set up a meeting with Jason, Roger, Trustees and the Mayor.

Trustee O'Connor says we will have the cameras and a decision on the compressor by next month.
