C. WATER DEPARTMENT:

Water Commissioner Iveson had a meeting at the water treatment plant with Lamont and Aztech that included Water Commissioner Iveson, Jason Priesner from Lamont and Aztech's Engineer and Foreman. Aztech was just bought out by a major company. They are still scheduled to do the work but there will be a setback timing wise because their demands are high elsewhere. They want to start with the filters and then move over to the clearwell portion

Trustee O'Connor made a motion to accept the resignation of the Lawn Artist and and enter into a contract with Caulfield Services at \$45/mow. Trustee Grenier seconded.
