- 2. MEETING CALLED TO ORDER: 7:12 PM

3. APPROVAL OF MINUTES:

4. REPORTS:

A. FIRE DEPARTMENT:

10 calls last month.

2nd Asst Chief Fink started working on the doors – realized he is going to need some other materials to finish the job. Should still be under the limit set last meeting.

A quote received for the fan - \$1862.62. Will need to get some quotes from some HVAC companies. Trustee O'Connor suggested asking Building Inspector Dale Warner if he knows any local companies that are reputable. It was also suggested to call Rick Peterson as well.

2nd Asst Chief Fink will touch base with Chief Morrison regarding following up with Brian on the lighting updates.

Trustee O'Connor mentioned to the board and the Fire Company that the DCPTA reached out looking to do a bonfire for Homecoming. The Fire Company will be contacted to be there potentially.

B. SCHENECTADY COUNTY SHERIFF:

Lt. Geraci could not attend.

Individuals involved in the break-ins have been arrested. Been guiet since.

Lt. Geraci also gave us the report of the speed camera. In a month, 30,916 cars went by. The fastest was 66 mph and it was one time. Average speed was 23.

C. TREASURER/CLERK:

Tax Collection for 2021-2022 season is complete. Relevied \$9800.17 over to the County to be added to the County Tax Bills.

Software is being sunsetted. We can continue as is, upgrade to Edmunds Tech, get quotes for others.

American Rescue Plan – we will have to amend the budget. Cannot be used for recurring expenses. Discussed putting together budgets on both (fan, water expenses) to attribute the funds to. Trustee O'Connor also mentioned the possibility of using it to train someone to replace Asst. Water Commissioner Micheli.

D. DEPUTY CLERK:

Report received.

Trustee O'Connor makes a motion to destroy records noted on the destruction sheet. Trustee Grenier seconds.

All on the board agree to make the expenditures to decorate for the fall as suggested by Deputy Clerk Grenier.

E. WATER DEPARTMENT:

Water Commissioner Iveson received the pump – trying to get it installed before Asst. Water Commission Micheli leaves (end of the month).

Switched Zinc awhile back – but after hydrant flushing, the water kept coming brown. Zinc reading is still low. Getting brown water on all the hydrants. Water use is still all over the place and the plant doesn't seem to be recovering, suggesting there is a leak somewhere. Reached out to the lab to see if the chemist has any ideas. Discussion regarding where a leak might be.

The YMCA has not yet reached out to Water Commissioner Iveson to discuss what they have been doing with the Y.

Water Commissioner Iveson wanted to note that there were major concerns with the break on East Shore – while the invoice seems low, he has concerns with the job that was done and just wanted to note to the Board he wasn't happy with the repair.

An engineering firm was at the lower reservoir; hired by DOT to assess the pipe. There is no bottom of the pipe currently. Water Commissioner Iveson informed the firm that they need to include the Village in any discussions.
