2. MEETING CALLED TO ORDER: 7:10 pm

3. APPROVAL OF MINUTES:

4. REPORTS:

A. FIRE DEPARTMENT:

10 calls; 9 made, 1 missed. 7 EMS, 1 car fire and 1 fire alarm and 1 mutual aide fire alarm.

A town resident offered to cut up the big tree in the parking lot if they could take the wood.

Breakfast was well attended.

Fire Dept is going to fix the flags that are falling down.

Assistant Chief Buccino has resigned. His position will remain vacant until next election. 2 new juniors and one additional application for another.

Brian Baker is doing the electric in the recreational room. The Fire Company will pay for that. 2nd Assistant Chief Fink will also discuss the fan installation with him and get a quote. The Village will pay the amount of the insurance claim and the Fire Company will pay the rest.

The Fire Company wants to sell the Argo and will also put together a list of radios to surplus as well. Village Clerk/Treasurer will look through our records to see if it was the Village or the Fire Company that bought that. The owner will determine what the selling procedure will be.

- B. SCHENECTADY COUNTY SHERIFF: Nothing to report.
- C. TREASURER/CLERK:

Financial reports submitted. Tax relevy onto the County has been sent in the amount of \$8063.84.

Clerk/Treasurer O'Connor continues to work to get the accounting software up and running; manual entries and balance issues.

Water rents have gone out.

D. DEPUTY CLERK: Report received.

The contract tracker has been updated to include amounts.

The Village Emergency Response Plan has been updated. Mayor Gifford will have to work with Water Commissioner Iveson to be sure all information is correct and up to date.

E. WATER DEPARTMENT:

The hydrant on Railroad Avenue has been repaired.

Water Commissioner Iveson is getting quotes and is finding the price has gone up. The price will be closer to \$6500. Hydrant locks will be \$140 a piece. The Board has stated that the purchase can happen.

Discussion regarding the labor rates for the Assistant Water Commissioner. The Board has decided to keep his rate the same as the previous Assistant Water Commissioner.

Water discoloration has continued to be a problem. Most residents have been understanding. It will really just be timing at this point to clear it up.

Water Commissioner Iveson spoke with the Health Department and they are all set with sand that was proposed.
