Water Commissioner Iveson is trying to get quotes on a sliding gate for the plant.

Water Commissioner Iveson has heard back from Fort Plain and they said it would be two to three weeks and then he can go pick up the sand washer. At that point, Steve Micheli will also be back from South Dakota to assist if needed. Discussion about whose equipment he would use to get the sand washer.

Water Commissioner Iveson is also working with Joe Coppola to see if he can assist with the pumps.

Water Commissioner Iveson notes the price for water tap in for the Loucks property will be \$2165.00 plus the \$35 permit. Add footnote to water permit application that additional fees for equipment and labor may apply if rock is encountered during excavation.
