3. APPROVAL OF MINUTES:

Village Board of Trustees Meeting Minutes July 10th, 2023

MOTION TO ACCEPT: Mayor Gifford 2nd: Trustee Grenier

Motion made to accept the minutes with changes noted.

4. REPORTS:

A. FIRE DEPARTMENT:

Report received. 4 calls for the month of August.

Mayor Gifford makes a motion to proceed with the exhaust fan replacement as long as the insurance approves of the location the fan gets mounted. Trustee Grenier seconds.

B. TREASURER/CLERK: Reports submitted. Tax collection is complete. Total tax relevy onto County tax bills is \$12836.06.

Working with an inside sales representative to purchase a laptop for Deputy Clerk Grenier, but it is a slow process.

D. WATER DEPARTMENT:

Discussion regarding the costs involved in washing the sand. The original budget provided was based on being able to use the Town of Duanesburg equipment. Now that is no longer an option and the budget will be larger. Water Commissioner Iveson states he will need 4 people for 3 days to complete the job. He was under the impression that the rate was already approved at \$65/hr but that was a previous approval for water main breaks and special projects for the Village employees, not for temporary help. The original budgeted labor was in the amount of \$2880, but Water Commissioner Iveson notes it will be more than that.

Mayor Gifford will ask Devon Freeland if he is interested in being the 4th person as he is already an employee of the Village. Water Commissioner Iveson will ask Vincent Braedner what rate he feels is appropriate and if he has insurance.

Discussion regarding the water discoloration and what options are available based on discussions with DOH, the lab, the chemist and Lamont Engineers. There are 4 other water plants experiencing similar issues. Currently getting discrepancies in advice from the engineer and chemists. If he does go down the path of injections prior to the filtration, he will need approval from DOH to proceed, but it will result in requiring more filtration bed cleanings.
