A. FIRE DEPARTMENT:

3 calls in June. 2 fire alarms and 1 mva.

New by-laws and new youth participation program from the attorney. Looking to implement them in August/September. Discussion regarding whether or not the by-laws need to be approved by the Village of Delanson Board of Trustees/Fire Commissioner. 2nd Assistant Chief Enders will ask the lawyer to site where he gets the information that the bylaws do not need to be approved by the Village.

Need sign off from the Village to amend the articles of incorporation in order to establish non-profit status. All Village Board of Trustees and Village Clerk O'Connor signed the document.

D. WATER DEPARTMENT:

The Village received two invoices from Affordable Water for water deliveries in early July. Discussion regarding whether or not these are correctly billed. Affordable Water is looking to get paid from the invoice that was sent out from the culvert project. That invoice has been sent to the State for processing, but the State has requested further breakdown on the invoice. Water Commissioner Iveson has let Affordable Water know that. Once that information is sent over, hopefully that invoice will be sent for payment. But, the Village cannot pay that invoice since it was already stated that the invoice would be paid from the Contractor/State from the project.

Discussion regarding the guardrail issue from the culvert project and what needs to be done to fix it going forward.

Jason Preisner has tested the new sand that was delivered and while it is coarser, it doesn't meet the exact specs he is looking forward. Would like Water Commissioner Iveson to change out one bed to see if that works. This is all to be reimbursed under Lamont Engineering's insurance due to the incorrect ordering initially. Water Commissioner Iveson will need to get the table for washing again, as well as some laborers for changing out the sand.
